General Information

Signature fees are based upon the costs associated with the different assessment methods used. All fees are reviewed annually.

Qualification Approval fees

An annual qualification approval fee is payable for each full qualification. When centre's seek approval for a qualification they will be approved for all units within that qualification.

When a centre seeks approval for 2 qualifications at the same time a 5% discount will be applied.

When a centre seeks approval for 3 or more qualifications at the same time a 7% discount will be applied.

An invoice will be generated when an application for renewal/approval is submitted online. Qualification approval fees are non-refundable.

Learner registration fees

Learner registration fees are payable for each learner, per assessment. An invoice is generated after the assessment date has passed.

A 30% discount will be applied to all learners who are 18 years of age or younger when the assessment takes place

Replacement certificates

Replacement certificates are available at a cost of £25 each to replace certificates that are lost, damaged in transit, or issued with incorrect names. Please note that replacement certificates will be marked as such. The name printed on the certificate is taken from the learner registration details. If this information is incorrect the certificate will also be incorrect. It is important that learner details are checked and Signature is informed of any amendments, before certificates are issued. For qualifications achieved prior to April 2020, we no longer issue replacement certificates. A confirmation of achievement letter can be issued in lieu of a certificate(s) at a cost of £10.

Appeals

Centres can request a breakdown of marks for certain assessments at a charge of £10. Centres can request a re-mark for learners who receive a fail result. Please refer to our Appeals Procedure available in IRIS and on the Signature website.

Withdrawal from an assessment for medical or bereavement reasons

Learners who withdraw from an assessment due to medical or bereavement reasons will be entitled to a full refund upon production of appropriate evidence.

If an entire session needs to be cancelled for medical or bereavement reasons, we will refund upon production of appropriate evidence.

Subject Access Requests (SAR)

Access requests will be provided at a cost of £10 per request. Please contact Signature for information on how to apply.

Administration fees

Where appropriate, a fee of £25 will be charged for any corrections or alterations required.
